Friendly News <u>Muncie Friends Church: A Quaker Meeting</u>

Quaker Trivia:

William Penn (1644 – 1718) was an English writer, religious thinker, and influential <u>Quaker</u> who founded the <u>Province of Pennsylvania</u> during the <u>British colonial</u> <u>era</u>. Penn, an advocate of <u>democracy</u> and <u>religious freedom</u>, was known for his amicable relations and successful treaties with the <u>Lenape</u> Native Americans who had resided in present-day <u>Pennsylvania</u> prior to European settlements in the state.

In 1681, <u>King Charles II</u> granted a large piece of his <u>North American</u> land holdings along the <u>North Atlantic Ocean</u> coast to Penn to offset debts he owed Penn's father, the admiral and politician <u>Sir William Penn</u>. The land included the present-day states of Pennsylvania and <u>Delaware</u>. The following year, in 1682, Penn left <u>England</u> for what was then <u>British</u> <u>America</u>. On this occasion, the colonists pledged allegiance to Penn as their new <u>proprietor</u>, and the first <u>Pennsylvania General Assembly</u> was held.

Penn then journeyed further north up the Delaware River and founded <u>Philadelphia</u> on the river's western bank. Penn's Quaker government was not viewed favourably by the previous <u>Dutch</u>, <u>Swedish</u> and <u>English</u> settlers in what is now Delaware.

As one of the earlier supporters of colonial unification, Penn wrote and urged for a union of all the English colonies in what later became the United States. The democratic principles that he set forth in the <u>Pennsylvania Frame of Government</u> inspired delegates to the <u>Constitutional Convention</u> in Philadelphia to frame the <u>U.S. Constitution</u>, which was ratified by the delegates in 1787.^[2]

A man of deep religious conviction, Penn was imprisoned several times in the <u>Tower of</u> <u>London</u> due to his faith, and his book <u>No Cross, No Crown</u>, published in 1669, which he authored from jail, has become a classic of <u>Christian</u> theological literature.

Treasurer's Report –Carolyn presented the February balance sheet of the Meeting finances. The General Fund continues to be reduced month by month. The Food Pantry has a balance of \$3000. The emergency Fund is at \$19, 420. The Building Fund is \$25, 587 after receiving a contribution; this balance will decrease after repairs are paid to the East Wing boiler. In total there is a combined balance of \$197,121, including the certificates of deposit. The treasurer's report was approved.

Stewardship & Finance – The East Wing boiler is finally repaired. Updated boiler permits have been submitted to the state. All Homeland Security requirements and building maintenance are now current, and ready to transfer ownership to Recovery Café. A complete report of all business transactions is always available in the church office. **Next committee meeting: Tuesday, April 8, 2024 at 2 pm.**

Ministry & Oversight – We are relying on presiders to guide our worship service. Dee Dee, Jan, Linda have served as presiders; Toni has offered to preside on the fifth Sunday. We would like to dedicate more time for traditional unprogrammed silent worship. All who might be interested are encouraged to reach out to the Ministry & Oversight Committee. Plans for an Easter breakfast was discussed and planned for April 20th at 9:30 am. We will move Monthly Meeting for Business to April 27th, since Easter falls on the third Sunday. **Next committee meeting: Thursday, April 3, 2024 at 2:00 pm.**

Community Outreach- we are staying current with the Muncie Resists Group through Carol Clendening as she is attending every meeting and event they are holding. There has been no change with Friends Food Pantry yet. A meeting with Recovery Café is planned for Monday, April 14th to discuss the merging of the two pantries.
